Peckham Platform is a creative and educational charity that connects art, people and place, bringing together local communities with leading artists to co-produce art projects with impact. This is an exciting opportunity for an aspiring Youth Co-ordinator with interest in the culture and/or heritage sector and working with young people, to support the growth and development of our Youth Platform and Schools Programme.

Purpose of Role:

Peckham Platform is seeking a passionate and organised **Youth Co-ordinator** to support our Head of Learning and Community Engagement with the delivery of our Youth Platform and elements of our Schools Programme.

The Youth Co-ordinator will play a key role in coordinating and supervising high-quality creative engagement opportunities that empower young people to develop and explore their creative interests, artistic, social and leadership skills. Working closely with artists, youth partners and education organisations, the postholder will ensure young people have supported access to creative progression routes and that their voices shape the programme's development.

This role requires someone with experience in youth engagement, collaboration, arts facilitation and partnership working. Above all we are looking for an individual committed to inclusivity, co-designing with community, care and creativity as tools for social change. Duties and Responsibilities:

Creative Access Programmes (CAPs)

- Coordinate and support logistics for six artist-led Creative Access Programmes (CAPs) with six partner organisations/schools, including scheduling, venues, materials and accessibility needs.
- Support artists and facilitators to create safe, inclusive and engaging creative sessions.
- Track participant attendance, engagement and any relevant accreditation.

Peer Network Development

- Support the recruitment and engagement of young people into the Peer Network.
- Support facilitation of the Peer Network sessions (every other month from February 2026) in partnership
 with the artists and relevant specialists, focusing on creative confidence, leadership and participant
 wellbeing.

Help young people co-design and co-lead public creative skills workshops and talks.

Placements & Mentorships

- Coordinate logistics for support placements, ensuring positive learning outcomes.
- Liaise with mentors and youth participants to facilitate mentorships per young person.
- Work with our cultural, heritage and education partners to connect young people with further opportunities.

Administration & Communications

- Support project documentation through photography, video and case studies.
- Maintain accurate records, debriefs, safeguarding logs, consent forms and contact data.
- Contribute to evaluation reports, funder updates and public presentations if/where required.

General Responsibilities:

- Coordinate the planning, delivery, and evaluation of Youth Platform activities in collaboration with the Head of Learning and Community Engagement and commissioned artists.
- Act as the first point of contact for participating young people, providing guidance, encouragement and support throughout their involvement.
- Maintain positive, professional relationships with project partners including schools, youth organisations, local authorities and creative institutions.
- Ensure safeguarding and inclusion are embedded in all programme activities.
- Support monitoring, evaluation and reporting processes to meet funder and organisational requirements.
- Represent Peckham Platform's values of equity, collaboration and creativity in all communications and community interactions.
- Undertake health and safety duties and responsibilities appropriate to the role.

- Proven experience working with young people (aged 14 25) from diverse and/or marginalised backgrounds in community or arts settings.
- Experience coordinating creative or participatory programmes, ideally within the arts, education, or community sectors.

- Strong organisational and communication skills, with the ability to manage multiple priorities.
- Confidence working collaboratively with artists, partners and education institutions.
- Experience of working with a small team and an understanding of collaborative working.
- Empathetic and adaptable, with the ability to build trust and motivate young people.
- Knowledge of safeguarding principles and willingness to undertake relevant training (Enhanced DBS required).
- Demonstrated commitment to equality, diversity and co-creation.
- An understanding of Peckham and/or Southwark and the communities that work and live in the area.

Desirable:

- Experience facilitating workshops or creative sessions for young people.
- Understanding of inclusive and trauma-informed youth work practice.
- Experience supporting evaluation and impact reporting.
- Lived experience of and connection to Peckham.
- Experience of working with marginalised and/or vulnerable people.

- Familiarity with Arts Award, digital badging, or youth accreditation frameworks.
